**The Criminal Justice (Proceeds of Crime) (Legal  
Professionals, Accountants and Estate Agents) (Bailiwick of  
Guernsey) (Amendment) Regulations, 2014**

THE POLICY COUNCIL, in exercise of the powers conferred on it by sections 49A and 54 of the Criminal Justice (Proceeds of Crime) (Bailiwick of Guernsey) Law, 1999<sup>a</sup> and all other powers enabling it in that behalf, hereby makes the following Regulations:-

**Amendment of regulation 30.**

1. In regulation 30(1) of the Criminal Justice (Proceeds of Crime) (Legal Professionals, Accountants and Estate Agents) (Bailiwick of Guernsey)

Regulations, 2008<sup>b</sup>, in the definition of "**terrorist financing**", for the words "section 2 or 3 of the Al-Qaida and Taliban (Freezing of Funds) (Guernsey) Ordinance, 2011", substitute "section 1(2) of the Afghanistan (Restrictive Measures) (Guernsey) Ordinance, 2011, section 1(2) of the Afghanistan (Restrictive Measures) (Alderney) Ordinance, 2011, section 1(2) of the Afghanistan (Restrictive Measures) (Sark) Ordinance, 2011, section 1(2) of the Al-Qaida (Restrictive Measures) (Guernsey) Ordinance, 2013, section 1(2) of the Al-Qaida (Restrictive Measures) (Alderney) Ordinance, 2013 or section 1(2) of the Al-Qaida (Restrictive Measures) (Sark) Ordinance, 2013".

#### **Interpretation.**

2. (1) The Interpretation (Guernsey) Law, 1948<sup>c</sup> applies to the interpretation of these Regulations.

(2) Any reference in these Regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

#### **Citation and commencement.**


3. These Regulations may be cited as the Criminal Justice (Proceeds of Crime) (Legal Professionals, Accountants and Estate Agents) (Bailiwick of Guernsey) (Amendment) Regulations, 2014 and shall come into force on the 29th July, 2014.

#### EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations update the definition of terrorist financing in the principal regulations to reflect recent changes to the Criminal Justice (Proceeds of Crime) (Bailiwick of Guernsey) Law, 1999 and bring the definition into line with international standards.

These Regulations come into force on the 29th July, 2014.
